In Russia

The Ministry of Health is in charge of medical universities, and the Ministry of Education is in charge of medical faculties in federal universities. Educational standards are generally the same, but learning content, rules, and interpretations differ from university to university.


The number of hours per credit, the number of credits earned, the total period of study, dissertation format, etc. Overcoming differences in credit systems and completion requirements in Japan and Russia

Arrangements for credit transfer

- 1. Conclusion of agreement (memorandum)
- 2. Compatibility of evaluation and management
- 3. Confirmation of syllabus
- 4. Identification of subjects of possible transfer
- 5. Credit transfer procedure

*Up to 15 credits from November 2020

◆The amount of learning per unit is greater in Russia
⇒transfer credits earned in Russia with applicable courses at Niigata University.
◆Curriculum and hours vary greatly depending on the field of specialization.

Order of the document that describes the courses student has taken and the class hours (number of credits) (рабочий учебный план), compare them with student's report card and choose the courses that can be transferred.

Expertise is required to understand Russian syllabus. Individual consideration is required for each person.

Challenges of Double Degree Program

	Graduation examination in Russia	Thesis paper • Public hearing • Final exam (Chief examiners • Vice examiners and Russian Steering Committee)

Since the doctoral program in Russia lasts 3 years, it is necessary to return to Russia once (period up to 3 months) for graduation examination and necessary procedures.

◆Schedule adjustment is difficult in fields involving research experiments
⇒A detailed research plan from the Russian side is required

- Differences in dissertation format and examinations
- It is extremely difficult to write a medical research paper in two years
