1. Program objectives

Tokai University has been taking a strong initiative to promote cooperation and expansion of the relationship between Japan and Russia for many years. This time, Tokai University has taken a new step forward to foster bridge personnel between Japan and Russia on Life Care through a special educational cruise project. The program of educational cruise consists of five types of activities: a series of lectures, on-board and in the city of Hakodate, project field work in Hakodate as a part of land-based program, culture and sport events, and on-board student forum. The main purpose of this program is to exchange individual opinions, to discuss together and to explore a better future from which both Japan and Russia can benefit in the viewpoint of Life Care. We look forward that every participant from Japan and Russia will enjoy sharing the time and the space together and could take a chance to get new knowledge and skills.

2. Program Theme

From the "New Normal" to the "New Future": Exploring Life Care for Socio-Economic Development of Russia and Japan.

Important: Please note that this program may be cancelled due to the COVID-19 epidemiological situation. The final decision will be made before no later than July. Even in case of cancellation, program will be transformed and adopted to the online format and implemented online under a similar time schedule. In this case, the participants enrolled are expected to participate at online program.

Eligibility criteria

- Undergraduate or master's student registered at one of the member universities of Association of Institutions of Higher Education of the Russian Federation and Japan.
- Citizen of the Russian Federation or Student of any citizenship (except Japan) enrolled at University of the Russian Federation.
- Not being currently a part of the inter-university exchange program of any institution.
- No older than 26 years old.
- Hight motivation to the program and understanding of aims of the Inter-University Exchange Project.
- Good English proficiency.

4. Application procedure

5. Fee 15,000 yen

The fee includes hotel, PCR test fee, food expenses, linen supply, and administrative expenses. Some students may receive financial support for local transport expenses to the designated meeting point (August 9) and from a port call (August 16). Results will be announced with final decision announcement and will depend on a status in Japanese universities.

6. Selection procedure

Step 1) Document-based screening

Only successful applicants will be informed by 4 June.

Step 2) Individual online interview

Online interview will be conducted in English and scheduled between 5th to 11th June.

Step 3) Final decision announcement

Only successful applicants will be informed by the beginning of July.

Frequently Asked Questions (HaRP)

Q) In case the program will be cancelled, what criteria will be used to make the decision and when the information will be announced?

A) The goal of this program is a student exchange between Japan and Russia, so it is necessary for the number of Japanese and Russian students participating to be approximately equal. Currently (as of May 1st) Japan is denying entry to foreigners from different countries including the Russian Federation. If this situation continues, citizen of the Russian Federation or Student of any citizenship (except Japan) enrolled at University of the Russian Federation who are already in Japan will become the target group for this program. The final decision about implementation of the program will be made by the end of June in accordance with the terms of number of participants from both countries and the epidemiological situation in Japan.

Q) What measures will be taken before and during the program in terms of preventing the spread of COVID-19 infection?

A) All participants will take a PCR test in 72 hours before the start of the program (PCR test fee will be covered by Tokai University). Also, after participants arrive at the meeting point, they will be asked to take a second PCR test and stay in a designated hotel for 24 hours before the start of the program (all costs will be covered by Tokai University). During the period of the program, one nurse and one public health nurse will be onboard to constantly monitor the health management of the participants.

Q) What protocols will be used in the case of detection of COVID-19 infected onboard?

A) In case of any injury or illness, not limited to COVOD-19, the onboard public health nurse and regular nurse will be first to respond. If there is a suspicion of an infection, contact with all other onboard members will be prevented through the isolation of the infected person in the onboard medical room or the isolation room prepared in advance. Furthermore, if it is determined that it is difficult to respond onboard, depending on the place of navigation, the vessel will head to the destination port or urgently enter an appropriate port and take necessary measures under the direction of the health center that has jurisdiction over the area. In that case, the program will be cancelled immediately. Return transportation will depend on the location at that time.



- Q) Will there be time for sightseeing or to meet friends in Hakodate during the program period?
- A) As this program is an educational training trip, basically free time is not considered at the land-based part of the program from the viewpoint of measures against COVID-19. Lectures and fieldwork are the main activities during the land-based part of the program. However, there will be free time during the onboard part of the program.
- Q) Is it necessary to participate in all program activities during the implementation period?
- A) Yes, except for health or other special reasons, participation in all activities including pre-training is mandatory.
- Q) <u>Is it possible to participate in only one part of the program (one way to Hakodate or Tokyo)?</u>
- A) Participation in all parts of the programs is an indispensable condition for application. All participants must commit to participation in the program if the educational cruise will be cancelled and replaced by an online program.
- Q) What about transportation costs? What costs are the responsibility of the participants?
- A) It will depend on the status of student in Japanese University. Some students may receive financial support for local transport expenses to the designated meeting point (August 9) and from a port call (August 16). Results will be announced with final decision announcement. Other costs, such as transportation in Hakodate and meals during the land-based part of the program, will be covered by the participants.
- Q) <u>Is it possible to participate in the program if the English language level of the participant is not high?</u>
- A) Yes, it is more important to have a desire to participate and express opinions in group discussions than to have high-level English.
- Q) What selection criteria will be used to choose the participants?
- A) Evaluation of the application documents and selection of the final participants will be conducted by Tokai University. First screening is based on the documents (eligibility checking, motivation



essay, etc.), and online interviews in English will be given as the second screening to all the applicants who pass the first screening.

- Q) <u>Is there Japanese language translation or support during lectures?</u>
- A) Lectures will be conducted in English, so there will be no support such as interpreting. In terms of daily life, we will provide support in English and Japanese on a case-by-case basis.
- Q) If a participant's PCR test is positive, what will happen?
- A) For this program, all participants must take two (2) PCR tests, the first72 hours before and the second 24 hours before the start of the program. If one of the PCR tests is positive, participation in the program is impossible. In that case, the participant is prohibited to board and should follow the instructions of the health center. The participation fee will be refunded in a few days.
- Q) What is the method of collecting the participation fee, the time of collection, and the availability of refund in case of cancellation?
- A) After the announcement of results of the selection, the staff in charge will send all necessary documents and instructions. After receiving them, participants must transfer their participation fee to the specified bank account by the deadline. The cancellation fee will be refunded in full only if the educational cruise will be cancelled by Tokai University. Refund of the participation fee due to personal reasons after payment is completed is not possible.
- Q) Will Tokai University provide travel insurance for all participants?
- A) Tokai University will enroll all the participants in a group insurance plan. Details of the insurance plan will be explained later. If participants feel that the group insurance plan is insufficient, they can purchase additional insurance with their own money.
