#### **Outline**

This workshop brings together researchers, public authorities, private companies, and NGOs interested in the economically, environmentally, and socially sustainable and responsible cruise tourism in land and sea areas including Hokkaido, the Russian Far East and the Arctic, the Sea of Okhotsk, the North Pacific Ocean, the Bering Sea and the Chukchi Sea. It follows the two-day online seminar with the same title held on 8–9 December 2021. Its first part focuses on domestic and international regulations, standards and guidelines affecting the development of the industry as well as on human resource development. The second part will be devoted to free discussion, allowing the participants to reflect and share their thoughts and ideas related to theme of the two online events. Furthermore, participants can exchange information on their own projects, events,

or initiatives related to the subject of the seminars.

It is hoped that this event will act as a forum for both knowledge production and networking. In other words, it will consolidate the existing knowledge and experience, help to identify the key challenges and opportunities that need further analysis and allow relevant actors from various countries to meet each other.
